FUND OBJECTIVE Seeks capital appreciation. The Fund pursues this objective through investment in equity securities of companies with the potential for above-average growth in earnings.

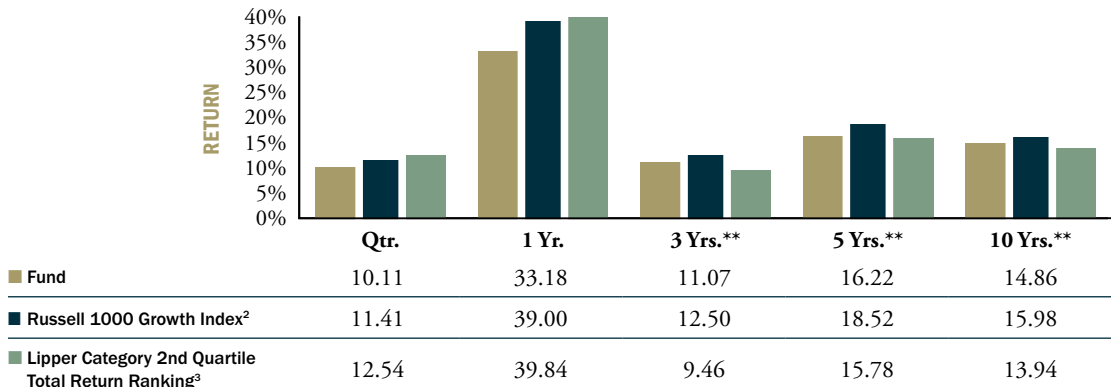
GROWTH FUND UPDATE

Following a strong rebound in equity markets last year, the first quarter would continue the advance, posting new all-time highs for the Russell 1000 Growth Index. Current economic releases still indicate moderate economic growth for 2024 and the prospects for a recession are pushed further into the future. The Commerce Growth Fund's return of 10.11% lagged the Russell 1000 Growth Index return of 11.41%.

Stock selection was a detractor from the Fund's performance. The Fund's strongest stocks were Vontier Corp (0.82%), Targa Resources Corp. (0.81%) and Travel + Leisure Corp. (0.83%), returning 31.36%, 29.66%, and 26.58%, respectively. The Fund's top detractors were Lululemon Athletica Inc. (0.87%), Zoetis Inc. Class A (0.90%), and Equity LifeStyle Properties, Inc. (0.80%), returning -23.60%, -14.07%, and -8.03%, respectively.

The Fund's sector allocation slightly detracted from the Fund's performance. The Fund's 1.08% overweight in the Materials sector, which returned 13.57%, added to performance as it was one of the stronger performing sectors. The Index has a 0.68% weight in the Materials sector. However, The Fund's 2.70% underweight in the Communication Services sector, which returned 17.33%, detracted from performance as it was one of the better performing sectors. The Index had a 11.78% weight in the Communication Services sector.

*** Lipper Analytical Services, Inc. is an independent publisher of mutual fund rankings, records rankings for these and other Commerce Funds for one-year, three-year, five-year, and ten-year total returns periods. Lipper compares mutual funds within a universe of funds with similar investment objectives, including dividend reinvestment. Lipper rankings are based on total return at net asset value and do not reflect sales charges. Lipper rankings do not imply that the fund had a high total return.

**** The Morningstar Rating™ is calculated for funds with at least a 3-year history based on a risk-adjusted return measure that accounts for variation in a fund's monthly excess returns. In each category, the top 10% = 5 stars, next 22.5% = 4 stars, next 35% = 3 stars, next 22.5% = 2 stars, and bottom 10% = 1 star.
