

GROWTH FUND UPDATE

The large cap growth market continued it's 2024 rally in the fourth quarter. Many investors focused on the positive implications of the two rate cuts in November and December by the Federal Reserve. Also, following the election, the tone for increased economic growth with less regulation in 2025 was viewed as a positive for forward earnings. The Commerce Growth Fund's return of 6.77% trailed the Russell 1000 Growth Index return of 7.07%.

Stock selection detracted from the Fund's performance. The Fund's strongest stocks were Deckers Outdoor Corporation (0.81%), GoDaddy, Inc. Class A (0.80%), and Spotify Technology SA (0.88%), returning 27.37%, 25.89%, and 21.4%, respectively. The Fund's top detractors were CDW Corporation (0.82%), Zoetis, Inc. Class A (0.89%), and Thermos Fisher Scientific Inc. (0.00%), returning -22.83%, -16.41%, and -14.42%, respectively.

The Fund's sector allocation was neutral for the Fund's performance. The Fund's 1.52% overweight in the Energy sector, which returned 13.37%, added to performance as it was one of the stronger performing sectors. The Index had a 0.44% weight in the Energy sector. However, The Fund's 0.98% overweight in the Health Care sector, which returned -9.00%, detracted from performance as it was one of the weaker sectors. The Index had a 7.13% weight in the Healthcare sector.
