
this objective through investment in equity investments of companies that are selling below fair market value compared to their future potential.

## **MIDCAP VALUE FUND UPDATE**

Following a strong rebound in equity markets last year, the first quarter would continue the advance, posting new all-time highs for the Russell MidCap Value Index. Current economic releases still indicate moderate economic growth for 2024 and the prospects for a recession are pushed further into the future. The Commerce MidCap Value Fund's return of 7.05% trailed the Russell MidCap Value Index return of 8.23%.

Stock selection detracted from the Fund's performance. The Fund's strongest contributors were Allison Transmission Holdings, Inc. (1.19%), Valero Energy Corporation (1.18%), and MKS Instruments, Inc. (1.23%), returning 40.03%, 32.31%, and 29.53%, respectively. The Fund's top detractors were Archer-Daniels-Midland Company (0.00%), C.H. Robinson Worldwide, Inc. (0.00%), and Air Products and Chemicals, Inc. (1.18%), returning -12.21%, -11.14%, and -10.87%, respectively.

The Fund's sector allocation performed in line for the quarter. The Fund's 0.62% underweight in the Communication Services sector, which returned -5.06%, added to performance as it was the weakest sector. The Index had an 3.08% weight in the Communication Services sector. However, the Fund's 1.49% underweight position in the Industrials sector hurt performance as it was the strongest sector, gaining 14.83% for the quarter. The Index had an 19.85% weight in the Industrials sector.
